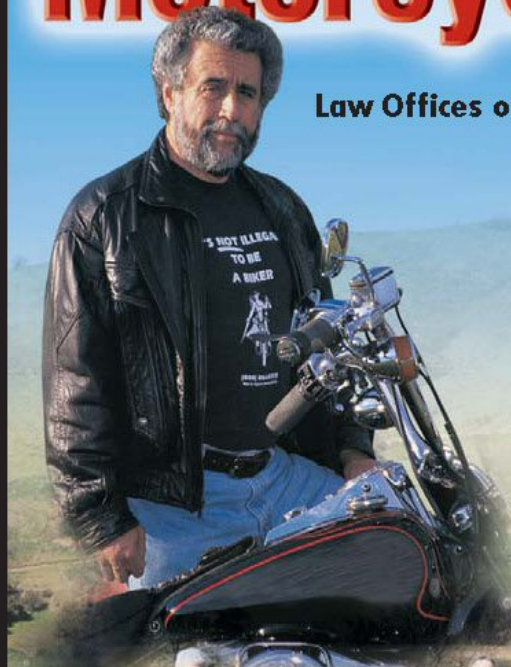

Candidate Criteria:

- 1) Nominated candidates must be aged 17 to 30 with a valid Motorcycle Endorsement on their Driver License. 31st birthday must fall after September of the year of consideration.
- 2) All nominees/recipients must either be a current member in good standing of ABATE of NY, or be an immediate family member of a current member in good standing of ABATE of NY.
- 3) Nominations will be accepted only from ABATE of NY members, and must be submitted on an ABATE of NY approved application form. Candidates may nominate themselves for consideration.
- 4) Nominations must be submitted between October 1st and May 31st, and postmarked no later than May 31st of the year for which the application is submitted.
- 5) Candidates must submit a minimum three hundred (300)-word essay detailing why motorcyclists' rights are important to them, and in what way their desired coursework will assist them in the ongoing fight for motorcyclists' rights. The essay should be included with the official ABATE of New York, Inc., Proner/ABATE Activist Scholarship Application Form. The winning candidate will be announced in an ABATE of New York, Inc. press release on or about August 1st, with presentation at the next regularly-scheduled ABATE State Chapters Meeting. Winning essays will be published in ABATE of New York's official publication, "The Freedom Writer" newsletter. Non-winning candidates will receive a letter of thanks encouraging them to reapply the following year, if eligible.
- 6) Winning candidate receives: a) \$1,000 check for use toward academic costs; and b) reimbursement for travel (federal mileage rate & tolls only) from residence to State Chapters Meeting location on date of award.
